Located in the UNESCO Dolomites World Heritage Site

San Cassiano is where a cocktail of Italian, Austrian and Ladin cultures come together in South Tyrol, Italy. It has three names: San Cassiano (to the Italians), St. Kassian (for German-speakers) and San Ciascian (in the Ladin mother tongue). The hotel is 10 mins walk to 1200 km of UNESECO heritage listed region and ski slopes of the dolomites. Included is a free hotel shuttle bus to and from the slopes.

### How to Get There:

Fly into any of following airports: Innsbruck, Verona, Venezia or Milano. Then drive or take a bus to the hotel. Parking is free at the hotel.

If travelling by rail, the nearest station is Brunico (37km / 50 mins drive away) while Bressanone and Bolzano are also within easy reach (65km /under 2 hours).

**Costs:**
